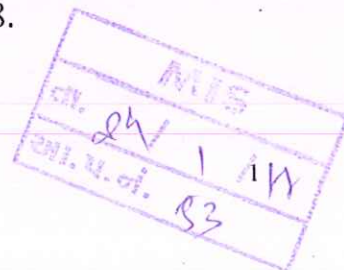

### **Agenda-2: To accord sanction to the Annual Work Plan and Budget (A.W.P. & B.) for 2017-18 of GCEE (SSA)**

The State Project Director presented the proposals of the draft A.W.P. & B. for the year 2017-18 under SSA, KGBV. He stated that Gujarat Government has regularized Vidyasahayaks as a regular teachers and GOG implemented the 7th Pay Commission so, salary component increased, which resulted a substantial rise in the Budgetary provision from Rs. 259135.02 lacs in 2016-17 to Rs. 406971.00 lacs (including spill over amount) in the proposed Budget for the year 2017-18.



E.C. took note of this and approved the proposed A.W.P. & B. for the year 2017-18 amount of Rs.406971.00 lacs.


The meeting ended with a word of thanks to the chair and members participate in the meeting.
