

# **Minutes of the 48th Meeting of the Executive Committee of Gujarat Council of Elementary Education (GCEE)**

---

The 48th Meeting of the Executive Committee of Gujarat Council of Elementary Education (GCEE) was held under the Chairpersonship of Smt. Sangeeta Singh, Principal Secretary, Primary Education, Education Department at 15:30 hours on 19th February, 2014 in the Conference Hall of the State Project Office, Sarva Shiksha Abhiyan, Gandhinagar. A list of members, who Participated in the meeting attached at Annexure-A.

After welcoming all the members of the Executive Committee, Shri Mukesh Kumar, State Project Director, Sarva Shiksha Abhiyan, in his opening address, remarked that, as specified in letter D.O. No. 7-10/2013-EE-17 dated 10.2.2014 from the Additional Secretary (SE), MHRD modified Agendas, including in the Agenda items of (a) progress on PAB commitments and (b) SSA progress under different components in compliance to RTE Act, 2009 as item No. 4, after the (1) confirmation of minutes (2) ATR on last meeting (3) physical and financial progress of SSA, are put up on the desk. Henceforth, items No.1 to 4 would become permanent in every E.C. meeting. He further observed that in Gujarat, as per the provisions of the Rules & Regulations of the Memorandum of Association (MOA) of Gujarat Council of Elementary Education (GCEE), the E.C. meetings are being Chaired by the Principal Secretary to the Government of Gujarat, Education Department and the formal notices for such meetings are sent in time accompanied with proper agenda notes to the Ministry of Human Resource Development.

## **Agenda : 1 : Confirmation of minutes of 47th meeting of the E.C. (12-11-2013)**

- 1.1 The minutes of the 47th meeting of the E.C. held on 12-11-2013 were confirmed as no members offered any suggestions or modifications.
  
- 1.2 On the issue raised by Dr.R.C.Patel, Nodal Officer, M.I., M.S.University of Baroda regarding the census figures produced in Annexure-C of Minutes are for the year 2001 and not latest for 2011, the State Project Director clarified that the category wise figures of census for the year, 2011 are not yet officially published, and hence last available census figures are produced.

- 2.1 The Action Taken Report was noted (Annexure- B)

## **Agenda : 3 : Physical and Financial progress of SSA**

- 3.1 The State Project Director presented the Financial Status i.e. sanctioned Budget provision v/s Expenditure incurred during the fiscal year 2013-14 under SSA, KGBV. He informed that during the year till January, 2014 total fund utilized was Rs.87446.85 lakh against the budget provision of Rs.137400.97 lakh, which is 64% of the total budget provision. Till the end of March, 2014 it is proposed to utilize Rs.106171.38 lakh, which would be 77% of the total budget. The unutilized amount of Rs.12416.76 lakh, pertaining to Civil Works would be spilled over to the next year budget.
- 3.2 On the issue of law coverage of Out of School Children in the area of AMC, Shri Desai, A.O. M.S.B., Ahmedabad stated that only about 4200 Out of School Children have covered under STP, while 5400 children which were shown as Out of School in the survey are found enrolled in the schools' registers and some others are beyond the age of 14 years. Therefore a gap in coverage of Out of School Children is appeared against the figures shown in survey. The State Project Director pointed out that this is a matter of concern and proper and serious efforts should be made to identify the correct and reliable figures of Out of School Children through the eminent NGOs and to achieve the targets.
- 3.3 On the issue of transport facility, the State Project Director observed that in AMC area transport facility has been provided only in the second term of the current academic year. This is not proper. Such practice should be avoided. He suggested to take advance measures, so as to enable the children to receive transport facility in time, i.e. from the first day of the beginning of the school in next year.
- 3.4 On the issue of delay in establishment of KGBVs, the State Project Director informed that the sanction of KGBVs was received in November, 2013 only. Moreover some delay was experienced in identifying the places to establish the KGBVs.

- 3.5 On the further issue regarding increase of per girl student maintenance grant, he informed that the matter to increase per girl student maintenance grant is under the active consideration at GOI level, and it would likely be finalized in the next fiscal year.
- 3.6 On the issue of maintenance / repair grant for KGBVs building as no provision under this head is made under S.S.A. Budget, the Director of Primary Education has agreed to carry out such activities from the available maintenance grant under the Budget of Director of Primary Education.
- 3.7 On the issue raised by Dr. R.C. Patel, Nodal officer, M.I.,MSU of Baroda regarding STP centres in Surendranagar ran for only 2 or 3 children, Shri Joshi, OIC-AS informed that the centres are run during the school hours, where children are also get benefit of MDM.
- 3.8 On the issue regarding provision for free Text Books, it was informed that Text Books for Std. I to VII are provided under the State Budget. SSA provides Rs.250 only per set per student for Std. VIII only. The Director of Primary Education agreed to provide the excess cost beyond Rs.250 per set per student from the State Budget.
- 3.9 On the issue raised by Dr. R.C. Patel, Nodal Officer, M.I., MSU of Baroda regarding study on learning outcomes of Pragna initiative, Shri Desai Convener, Q E Cell informed that a study is being conducted by MHRD with the support of UNICEF for Activity Based Learning (ABL) in seven States where the programs introduced. Gujarat is one of the State in seven States, where the ABL is being introduced. For this task training to human resource persons have been imparted by the Education Initiative (EI) in January 2014. The field work of the study is underway and likely to be completed at the end of February, 2014.
- 3.10 On the issue, whether Home Based Education provided to CWSN by the care-givers achieves regularly and success to CWSN. It was agreed to carry out 3<sup>rd</sup> party checking on the services provided by care-givers engaged under Inclusive Education as per RTE norms.

- 3.11 It was also agreed to inform district level IED co-ordinators to cooperate and guide the CWSN in getting benefits like scholarships, financial and other aids from the schemes available at various sources for CWSN.
- 3.12 On the issue raised by Shri D.B. Vyas, Superintendent Engineer, GWSSB, regarding delay in Construction / reconstruction of school buildings, the State Project Director informed that reconstruction of dilapidated school buildings which are beyond major repairs and declared unsafe by the competent Engineers and demolished by the concerned authority are carried out under SSA. In short, SSA is not directly involved in demolition of non-reparable school buildings. In such cases, SSA has to wait for the Site clearance, which is one of the reasons for delay in carry out construction work. However care is being taken to avoid delay.
- 3.13 On the issue regarding establishment of more KGBVs in EB Blocks, the State Project Director informed that additional proposal for more 30 KGBVs in EB Blocks has been proposed in the next year Budget. Dr. R. C. Patel, Nodal Officer M.I., MSU of Baroda and Dr. Tatvamasi, Assistant Professor, SPISER remarked that KGBVs run under SSA performs well than those run under M.S.

#### **Agenda : 5 : To accord sanction to the proposals of AWP&B for SSA, NPEGEL and KGBV for the year 2014-15.**

- 5.1 A presentation on the proposed AWP&B for the year 2014-15 was made, which was agreed by the E.C, with a remark that if the State policy for fix pay packet of the teachers which is at present Rs. 5300/- p.m. is changed the provision of salary amount of teachers in budget would be increased accordingly.

6. In the discussion that accompanied the presentation, the Chair made the following suggestions.
- 6.1 Immediate actions be initiated to acquire the land for construction of 3 KGBVs, which is still not started.
  - 6.2 Procedure for deployment of Science and Maths teachers in KGBVs be carried out and completed before the start of the next school term.
  - 6.3 Quality check on drinking water in primary schools and action plan for problem areas for coordination with WASMO. WASMO agreed to the suggestion for problem area listing primary school supply in villages as regular check points.
  - 6.4 Transparent software for teacher transfer be developed for implementation by next transfer season with help of BISAG. School wise monitoring to be carried out and redressal for problem schools be inbuilt with Director of Primary Education action plan for transfer with data being provided by SSA.
  - 6.5 Self defense training to upper Primary Girls in schools may be imparted in coordination and with help of Sports Department and district level officers of Physical Education.
  - 6.6 ERP for Gunotsav and On line Child Tracking System for learning outcomes to be developed on priority with analysis of upcoming Gunotsav-4 External Evaluation results.

At the end, SPD thanked all the participating member of EC including the staff members.
